DESIGN PHILOSOPHY OF REFLECTIONS *Architectural Guidelines Article 1: Section 1*

Reflections was conceived as a project which would enhance the natural order of gracious living. The vegetation, terrain, and lakes were recognized as assets; their artful preservation is fundamental to the Reflections design Concept. The placement of Utilities underground eliminates the visual clutter common in most communities. Roads have been carefully placed to take advantage of the existing topography. The inclusion of a variety of types of homes accommodates a generous range of lifestyles.

The structures are sited to allow large areas of common property to be left in their natural state or developed for recreation. Each unit is oriented for maximum privacy, affording views of the lakes or woods and vistas through open areas. The provision of an enclosed service yard of most houses hide such unsightly things as trash containers and heat pumps. This, too, adds to the pleasant aspect of the community.

DID YOU KNOW...

Yard Waste Collection

Yard waste is collected weekly and should be placed in one pile within 6 feet of the curbside and not in the **traveled** part of the roadway, storm drain or drainage ditch no later than 7 am on your scheduled service day.

What will be collected:

Grass Clippings; Leaves; Pine Straw (no mulch); **Sticks or small limbs** (no longer than **4 feet** and no bigger than **4 inches** in diameter); **Brush or clippings generated from routine landscape maintenance of residential properties** (no stumps, roots or tree removal debris will be collected).

How to prepare your yard waste for collection:

Weekly collection will be limited to a pile no larger than **6 feet in length, 3 feet in width and 2 feet in height** OR roughly the amount of two loosely filled roll carts OR **six 30-gallon yard waste bags**. **Please keep your yard waste at least 3 feet** from other carts, containers, cars, mailboxes and other obstructions that may prevent pick up. **If you have additional yard waste or larger yard debris**, visit a county drop center for disposal. If yard waste is found to be non-compliant, it will be tagged with a service notice with the reason why it was not collected and will need to be corrected. If not corrected, a citation may be issued and the property owner may be subject to fines.

Holiday Schedule for pickup

There will be **NO CURBSIDE COLLECTION** on **New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day and Christmas Day**. When collection is interrupted due to a holiday, your garbage, recycling or yard waste will be picked up the day following your usual pick-up day.
