A Note from the Manager's Desk

Discussions have come up about water shut-off valves in Original Reflections. Not all homes have them, and this can cause issues when there are water leaks or other instances where water to the home has to be temporarily stopped. I encourage you all in Original Reflections to first determine whether or not your home has a shut-off valve. Typically, these may be located in your service area, near water heaters, or utility areas but may also be located somewhere outside of your home. If you find that you do not have one, you will need to cut the water from your meter. Those are usually located near the curb, 2-3 feet from the edge and into the yard. In some neighborhoods, the meters are actually located behind the homes. If you cannot locate your meter, please call the City of Columbia water department at 803-545-3300, and explain that you need assistance locating your meter. They will send out a technician who can locate and show you how to operate the valve. If you want to install a shut-off valve to your home, you will need to contact a plumber.
